

2019 GSS Fete Day Cash Card - Terms and Conditions

1. INFORMATION ON WHO WE ARE AND THIS AGREEMENT

- This Agreement sets out the general Terms and Conditions that apply to the prepaid GSS Cash Card (“Card”). This document forms an Agreement between You and Graceville State School P&C Association (“Us” / “We”) governing the possession and use of the Card. By purchasing and using the Card, you agree to the Terms and Conditions in the Agreement. Copies of this Agreement can be found on the Fete Website or in the School Office.
- GSS Cash Cards are issued by the Graceville State School P&C Association. The Graceville State School P&C Association is regulated and authorised by the Education (General Provisions) Act 2006 and under that Act declared a Statutory Body under the Statutory Bodies Financial Agreements Act 1982.
- The production of Cards has been outsourced to Flash Printing, however the design is managed by the Fete Committee.
- This Agreement will commence on the Commencement Date for a Card and will terminate in accordance with Condition 7.
- This Agreement and all communications between Us and You shall be in the English language.

2. CARDS – Pre-purchase

- The Card is a prepaid payment card which may be used to pay for goods and services at Participating Stalls at Graceville State School on Fete Day between the hours of 09:00am and 07:30pm.
- Cards are **NOT** accepted at any of the Quad Market Stalls, Parents and Students’ Market or the Slushie Van on Fete Day.
- Each Card will have a maximum value of \$10 with 10 denominations of \$1 each.
- At a cost of \$10 per Card, they can be pre-purchased from the School24 Website during the Pre-purchase Period. Once purchased, the Cards will be sent home in your child’s KIT folder in the week commencing 19/08/2019.
- Cards cannot be purchased on the School24 Website after the expiry of the Pre-purchase Period but can be purchased from the Fete Card Stall on Fete Day.
- You must take a note of the confirmatory email once the purchase has been completed. This may help you in case you do not receive the Cards for some reason.

3. CARDS – On Fete Day

- At a cost of \$10 per Card with 10 denominations of \$1 each, Cards will also be available for purchase on Fete Day at the Fete Card Stall either by paying cash, credit or debit card.

4. GSS Cash Card Prize Draw

- There will be a GSS Cash Card Prize Draw on Fete Day. Once a Card has been fully used, to enter the draw the owner needs to write their name and mobile phone number on the used Card and put it into one of the GSS Cash Card Prize Draw boxes that will be at numerous Fete Stalls and also where the MC is located.
- Intermittently on Fete Day, a Card will be drawn and the MC will announce the winner’s name. A text will also be sent to the winner, who will have 30 minutes to collect their prize. If the prize is not collected with the 30 minute period, it will be redrawn.

- Cards that are refunded will not be eligible to enter the GSS Cash Card Prize Draw.

5. HOW TO USE THE CARD

- A Card may only be used by the person or his family to whom the Card was issued.
- The Cards are non-transferable, and You are not permitted to allow any other person to use the Card. Prior to use, the Card should be signed on the back of the Card.
- All payments made using Your Card shall be in the currency of the Card, i.e. AUD.
- You must ensure that You have sufficient Available Funds on the Card to pay for each purchase.

6. LOST CARDS

- GSS Cash Cards are as good as cash on Fete Day. If you lose a Card, the Fete Committee or the school P&C will not be responsible to issue a replacement Card. However, do report any lost Cards at the Lost and Found Counter.

7. EXPIRY OF THE CARD

- Your Card will expire at 07:00pm on FETE Day. After this time the Agreement (except clauses conditions 8 and 9 which survive termination) will terminate and the Card will cease to function and You will not be entitled to use the Card.

8. REFUND PROCESS

- You are entitled to a refund of Available Funds on your Card/s any time from the Commencement Date until the Refund Date.
- A refund of Available Funds on your Card/s can be provided to You on Fete Day at one of two locations, 1. the GSS Cash Card Stall between the hours of 09:00am and 07:00pm AND 2. the GSS Cash Card Refund Stall in the Quad Market between the hours of 09:00am and 03:00pm.
- After Fete Day, a refund of Available Funds on your Card/s can be provided to You if you put any unused Cards in an envelope with bank account details to which the refund will be paid, and leave this envelope in a designated box at the School Office before the Refund Date.

9. LIMITATION OF LIABILITY

- None of GSS, the Graceville State School P&C Association or the Fete Committee will be liable for:
 - any fault or failure relating to the use of the Card that is a result of abnormal and unforeseeable circumstances beyond Our control which would have been unavoidable despite all our efforts;
 - the goods or services that you purchase with Your Card;
 - any loss of profits, loss of business, or any indirect, consequential, special or punitive losses; and
 - the sums incorrectly deducted from Your Card.

10. YOUR PERSONAL INFORMATION

- You consent to us collecting information about You, the purchaser and the users of the Card, in order to operate the Card programme.

11. CHANGES TO THESE TERMS AND CONDITIONS

- This Agreement may be changed or amended by Us at any time for legal, regulatory, commercial or security reasons or to enable the proper delivery of or to improve the delivery of the Card programme.
- If any changes are made they will be publicised on the Fete Website.

GSS CASH CARD TERMS AND CONDITIONS DEFINITIONS

- **“Agreement”** means these Terms and Conditions as amended from time to time and contemplated in condition 11.
- **“Available Funds”** means, at any given time, any unspent funds loaded onto Your Card.
- **“GSS Cash Card”** or **“Card”** means a money card issued by Us to You.
- **“Fete Day”** means the day when the Fete will happen at Graceville State School i.e. 24/08/2019.
- **“Commencement Date”** means the date on which the Card was purchased.
- **“Fete Website”** refers to <http://gracevillessfete.com.au/>
- **“Participating Stalls”** means Stalls run by the Graceville State School classes on Fete Day and which expressly excludes Stalls run by external operators such as the Quad Market, Parents and Students’ Market and the Slushie Van.
- **“Pre-purchase Period”** means the period from and including 29/07/2019 to and including 15/08/2019 at 10:00pm.
- **“Refund Date”** means 31/08/2019.
